Motion to pay Vouchers made by Paul, 2nd Chuck, David: 3 approvals, Motion Approved.

30 East Main St Unit 4 – Windows are expected to be available for pick up on or around December 5th. The spike in COVID cases along with a company merger between Lanser and Harvey has caused a delay in the production of our windows. David Foss, David Foss & Sons LLC, believes he will need just one week to complete the work, and plans to start the work as soon as the windows are available. Dianna has obtained a building permit and has

placed it in the unit. Dianna and Les, Building Inspector, will monitor work. The board also discussed the need for 3-bedroom rentals in the area and will vote on whether to rent or sell the 'affordable' units at out next meeting on 12/16/2020

32 Lisa Lane – Rescon Basement Solutions was out at Lisa Lane and determined that a full french drain system would solve the water/mold issue in the basement. We received a quote of \$23,130.00. Dianna will speak to Mike, Town Administrator, on the process of entering into contract, or if we are required to get quotes from other companies. According the Mass Law Chapter 30B, a contract valued between \$10,000 and \$50,000 requires that bids be solicited from (bid info sent to) at least 3 vendors, but 30B allows selection if only 1 or 2 actual quotes are received back from vendors.

Motion to enter into contract with Rescon Basement Solutions not to exceed the amount of \$25,000.00 with Dianna Twomey as signature representing the AHT, pending the outcome of contract process, was made by Chuck, 2nd Paul, David: **3 approvals, Motion Approved**

65 Central Street – seems to be in the final stages of completing project. Les, Building Inspector, has put the AHT oh his checklist before issuing an occupancy permit. We are expecting \$157,000.00

Housing Choice Small Town Capitol Grant – an application will be submitted with the basement repair at 32 Lisa Lane as the AHT 'project'. Applications must be submitted by December 8th. Awards are expected to be announced in February 2021.

CPC Grant - David will request \$98,000.00 from the CPC
