66 Parish Road – To keep the design character of the development similar, John Colantoni, Developer, has a plan to construct a multiunit home that appears as a single family. This plan is in the design stage and would need to be brought back to the Planning Board for approval. In doing this, the AHT would receive two units as an alternative to one.

Tim made a motion to work with Developer, John Colantoni, to acquire a second 2-bedroom affordable house unit located at 66 Parish Road. The cost to the Affordable Housing Trust to acquire the property will be the difference between fair market value and the affordable value but said difference not to exceed the amount of \$215,000.00. The developer also agrees to establish a sperate reserve within the condo association for exterior maintenance for both units. Furthermore, the developer also agrees to be solely responsible to facilitate the affordable lottery sale of both units through the DHCD using maximum resale price for an affordable unit(s) using Lawrence, MA-NH HUD Metro FMR Area calculations and include having both units on the Subsidized Housing Inventory (SHI) 2nd by Chuck, Tim, David: 3 Approvals, Motion Approved

51 West Street – Sedler's. The AHT will receive an in lieu of payment for the construction of the 7 condominiums that are currently under construction. The calculations of the in lieu of payment will be made pending the sale price of the units.

188 East Main Street- David Trembly has not received the decision from Building Inspector. He is considering scaling down the project. He will continue to update the AHT.

9 Horsemint Circle – Sold. The AHT will need a copy of the completed Deed.

30 East Main St Unit 4- Contact tenants regarding rent and utilities.

CPC – No update. Transfer of funds. Tim will follow up with Mary, (Town Accountant), and Alex (Town Treasurer)

HPP – MVPC will be moving forward with our grant request to update our HPP that is set to expire the end of 2022
