Fowler made the motion due to safety concerns as discussed at the Monday, August 17, 2020 Selectman's meeting citing the facts that the Governor of the State of Massachusetts has declared the Town of Georgetown a yellow area of risk, and the concerns of the Police Chief Cudmore, about activity at the Towns' American Legion Park area and future—with the emergency declared by our Governor and we the Board of Selectman due to the Covid 19, that we need to take action to protect the safety of our residents while at the American Legion Park and to avoid the risk of large outside gatherings, that we the Board of Selectman close the playground, beach and other areas of gathering such as the picnic tables, pavilions connected to the beach area fir non-residents of Georgetown, motion was made under the Emergency Act that we are in this time and that this closer would be in effect until our next regular scheduled Board of Selectman meeting where the Board can discuss the situation and take action at that time, motion was seconded by Mr. Kershaw. Roll call vote was taken all in favor.
