OLD BUSINESS

 Healthy Pharms Update – Sel. Dawes and TA Farrell met with HP principals Paul and Nat Averill to discuss the potential impact on the host agreement with HP if another cannabis growing facility was granted a permit in Georgetown. Section 28 of the agreement states if a second RMD opens in Town the payments by HP get cut in half. The Town understood RMD to mean a dispensary and would not apply to a grow only facility. HP's position is the state's definition of a RMD includes both dispensaries and grow facilities and they are entitled to the reduced payments. However, they would be willing to waive that right as long as the Town supports their application to sell recreational marijuana and does so very expeditiously.

An ensuing discussion took place but no decisions were made.

Greenbridge Medical Marijuana Discussion

Two of the principals of Greenbridge, Rick McDonald and Mark DeAngelis, in a followup from their presentation to the Board on July 10th, indicated they would like to receive a letter of non-opposition to their plans to establish a medical marijuana grow facility at 16 Carlton Drive before the Board's next scheduled meeting on August 21st.

The board's position is before that could happen a host agreement would have to be agreed to and signed by the parties. McDonald felt that was doable. The Board asked Sel. Dawes and TA Farrell to get on it right away.
