Greg Hochmuth; Engineer representing the applicant: We have responded to both letters from Gillian. Issues regarding erosion and sedimentation control and the invasive species plan – we did everything Gillian asked plus a watering plan. We eliminated 4 parking spaces adjacent to the new septic system that went in. We added 4 additional trees and 15 additional shrubs. We moved the dumpster to the front area per the fire code.

C. Shreder: I would like to specify the environmental snow melt materials. It is a difficult site. I think you have done a pretty good job given the challenges. You have come up with reasonable changes.

{Applicant's Contractor Paul Shilhan discusses the plan with the Conservation Commission and the Conservation Agent. They discussed septic setbacks and no cut zone, slope, mulch bed, drywell, drainage, 6 trees (white pine, oak) that need to be removed, pervious pavers, soil enrichment, planting mitigation, extending the naturalized edge up to the pool and making it deeper. There applicant agreed to save the large oak tree, and will landscape around it with perhaps dogwoods or a similar tree and native plantings.}
