With regret, board members accepted a letter of resignation COA Alternate Board member Janice Downey. Board member Diane Prescott moved to accept the letter of resignation with a second by Board member Sue Clay. In an update of the Georgetown Senior Community Center, Colleen reported that an issue with the HVAC unit in the pool room as well as an issue with the telephone in the library/game room have both been resolved. Although the state has yet to set the amount of money planned for the state Formula Grants, the application is expected soon and Colleen is at work on both the state's Annual report and the Town's annual report. Colleen has prepared a comprehensive Safety and Standard Operating Procedure (SOP) Protocol that has been shared with the Police and Fire Departments. The board accepted the Safety and SOP Protocol with a motion by board member Darcy Norton and a second by Ann Stewart. Since the move to the Senior Center, the COA continues to experience a 50 percent increase in participation in COA programs and activities.
