The meeting was called to order at: _12:30 p.m		
Minutes from the December 22, 2020 Meeting were reviewed and approved with one adjustment (attendance).		
(Date) Meeting Motions / Actions and Summary of Discussions:		
Colleen reported money received by the Town from the Federal CARES Act has covered the purchase of some facility COVID updates such as touchless faucets, paper towel dispensers, masks, gloves, hand sanitizing stations and sneeze guards at the Senior Center. Issues with the cafeteria heaters/AC units were presented to Mike Anderson, Director of School Facilities. He recommended replacing the units with one wall unit for \$1,800. The proposal was approved by Town Administrator Mike Farrell and will be installed by the School Facilities Dept. Applications for this year's Tax Incentive Program are complete. Positions have been filled. Two remaining openings should be filled by Oct. 31. Income Tax preparation appointments are being scheduled. The program will run Feb. 18-April 16. Participants will have telephone interviews and will be scheduled to drop off and pick up their documents on the same day at the Senior Center. Participants will not leave their cars. Over 40 people have signed up for the no-fee service. A grant for outreach and nutrition from ESMV has been extended until April. This allows the COA Food Pantry to stock up paper products, non-perishable food and personal hygiene and plan themed distribution within the community. Organized by Our Neighbor's Table in Amesbury, a regional grant to address food insecurity is moving forward with some capital items but will not include a centralized food hub location at this time. The \$175,859 Annual COA Budget for FY22 was reviewed. In a motion by Sue Clay with a second by Dare Nibansky, board members accepted the FY20 Annual Report. In a motion by Sue Clay with a second by Dare Nibansky, board members accepted the Treasurer's Report. Colleen said the Board of Health has asked the COA to gather a head count of seniors interested in receiving the COVID-19 vaccine at a local clinic.
