EAST MAIN STREET RECREATIONAL FACILITY REGULATIONS

TO PROTECT THE PUBLIC SAFETY IN THE USE OF TOWN FIELDS, THE FOLLOWING RULES AND REGULATIONS SHALL APPLY:

NO TRESPASSING IS ALLOWED.

THE FIELDS ARE OPEN FROM DAWN UNTIL DUSK, UNLESS THERE IS WRITTEN PERMISSION GRATED FOR OTHER TIMES BY GEORGETOWN PARK & RECREATION COMMISSION.

NO SMOKING, VAPING OR ELECTRONIC CIGARETTES ARE ALLOWED. NO ALCOHOL MAY BE POSSESSED OR SERVED AT ANY TIME, UNLESS WRITTEN PERMISSION BY BOARD OF SELECTMEN AND POLICE DEPARTMENT HAS BEEN GIVEN.

NO VANDALISM IS ALLOWED.

NO LITTERING IS ALLOWED. PLEASE PLACE TRASH IN BINS PROVIDED OR CARRY IN/CARRY OUT.

SHIRT AND SHOES ARE REQUIRED AT ALL TIMES.

ALL DOGS MUST BE ON A LEASH IN THE EAST MAIN STREET RECREATIONAL FACILITY PARKING LOT UNTIL THEY ARE INSIDE THE GATED DOG PARK AREA.

GEORGETOWN POOPER SCOOPER LAW APPLIES. PLEASE PICK UP AFTER YOUR DOG.

OFF-LEASH DOG AREAS - REGULATIONS

- 1. The park hours of operation will be posted by the town of Georgetown.
- 2. Owners or custodians are responsible for all actions of their dogs.
- 3. Dog handlers must be at least 16 years of age or older.
- 4. Children under the age of 10 years old are not permitted in fenced area for safety reasons.
- 5. The owner or custodian of the dog must remain in the dog area with the dog.
- 6. All dogs must be legally licensed and have a current rabies vaccination.
- 7. All dogs must be leashed upon entering and leaving the off-leash dog areas.
- 8. Dogs in heat or younger than 4 months are not allowed in the park.
- 9. Dogs must be removed at first sign of aggression to other dogs or humans.
- 10. No pronged training collars of choke chains allowed.
- 11. Dog feces must be cleaned up by the dog owner or custodian.
- 12. Holes dug by dogs must be filled by the dog owner or custodian.
- 13. No glass containers or food of any kind are permitted in the park.
- 14. Violators are subject to removal and/or exclusion from the dog park.

TO PROTECT THE PUBLIC HEALTH AND SAFETY, ONLY SERVICE ANIMALS ARE ALLOWED AT THE SKATE PARK, RECREATIONAL FIELDS AND COMMON AREAS.

ALL PICNIC TABLES ARE FIRST COME/FIRST SERVE UNLESS WRITTEN PERMISSION BY GEORGETOWN PARK & RECREATION COMMISSION HAS BEEN GIVEN.

BICYCLES ARE ONLY ALLOWED IN PARKING LOT AND DESIGNATED BIKE RACKS.

SKATE BOARDS ARE ONLY ALLOWED IN SKATE PARK AREA, STRICTLY ENFORCED.

MOTORIZED VEHICLES OF ANY TYPE ARE NOT ALLOWED ON THE RECREATIONAL FIELDS UNLESS APPROVED BY THE GEORGETOWN PARK & RECREATION COMMISSION.

NO OPEN FIRES OR PERSONAL GRILLS ARE ALLOWED IN THE ENTIRE RECREATIONAL FACILITY UNLESS WRITTEN PERMISSION BY GEORGETOWN PARK & RECREATION COMMISSION AND THE GEORGETOWN FIRE DEPARTMENT.

EXCLUSIVE RECREATIONAL FACILITY USE FOR THE ATHLETIC FIELD, DOG PARK, SKATE PARK, COMMON AREAS, PICNIC TABLES AND PARKING LOT MUST BE RESERVED IN ADVANCE WITH WRITTEN PERMISSION BY GEORGETOWN PARK & RECREATION COMMISSION.

EAST MAIN STREET RECREATIONAL FACILITY IS MANAGED BY GEORGETOWN PARK & RECREATION COMMISSION.
