SUBJECT: Response to Comments by Ron Müller & Associates
Proposed Transfer Station
Carleton Drive, Georgetown, MA

Dear Mr. Cashell:

Greenman-Pedersen Inc. (GPI) previously prepared a *Traffic Impact and Access Study*¹ (TIAS) and *Updated Traffic Impact Analysis*² submitted to the Planning Board for the proposed transfer station to be located on Carleton Drive in Georgetown, Massachusetts. Following review of these documents, the Town's traffic peer review consultant, Ron Müller & Associates (RMA) requested that additional traffic count data be collected along Carleton Drive to obtain existing daily vehicle trips and truck trips. In addition, RMA requested that GPI collect empirical trip generation data at similar waste & recycling transfer facilities with a capacity of over 500 tons per day to compare this data to the trip generation estimates contained in the *Updated TIAS*. This letter is intended to respond to that data request.

Carleton Drive Traffic Counts

As part of the *TIAS*, GPI previously collected Automatic Traffic Recorder (ATR) counts on Route 133 just east of Carleton Drive, as well as vehicle turning movement counts at the Route 133 / Carleton Drive intersection during the weekday AM (6:00 AM – 9:00 AM), weekday PM (3:00 PM – 6:00 PM), and Saturday midday (11:00 AM – 1:00 PM) peak periods. As part of the peer review, RMA requested that additional traffic count data be collected along Carleton Drive to assess the total daily and peak hour traffic volumes, as well as the number of existing trucks utilizing the roadway. To respond to this request, GPI collected an ATR count on Carleton Drive just east of Route 133 on Friday, March 19, 2021 to Thursday, March 25, 2021 to obtain a full week of count data. The detailed traffic count data is provided as an Attachment to this letter and the results are summarized in Table 1 below.

Empirical Trip Generation Data

Many of the residents and business owners within the Town of Georgetown have expressed a concern that the proposed G Mello facility could generate ten times the volume of traffic that the existing facility generates as the processing capacity of the facility will be increased from 50 tons per day to 500 tons per day. GPI's *Updated TIAS* and the peer review letter's from L.H. Graham Associates explained that the proposed facility will be able to accommodate larger roll-off and packer trucks that carry a greater amount of material per vehicle. This will allow the facility to increase its processing capacity without significantly increasing the number of vehicles generated. To address the concerns raised by residents and business owners, RMA recommended that the Applicant collect empirical trip generation counts at similar facilities with a capacity of over 500 tons per day to verify the trip generation assumptions contained in the TIAS.

Based on discussions with GPI and RMA, two locations were identified as having similar characteristics to the proposed G Mello facility in terms of the types of materials receiving, and receipt of residential waste and recycling, as well as commercial and construction waste. In addition, both of these facilities are standalone facilities with driveways serving only the individual business, making it easy to distinguish site-generated trips from other area traffic. These sites included the Casella Waste facility on Hardscrabble Road in Auburn, MA, which has a capacity of 650 tons per day, and the Covanta Semass facility on Cranberry Highway in Wareham, MA, which has a capacity of 1,200 tons per day.

Automatic traffic recorder (ATR) counts were collected on the driveways to the Casella Waste facility in Auburn on Thursday, March 18 to Monday, March 22, 2021 in order to collect daily and peak hour volumes on a weekday and Saturday. Similarly, ATR counts were collected on the driveways to the Covanta Semass facility in Wareham on Thursday, March 18 and Friday, March 22, 2021 to collect daily and peak hour volumes on a weekday. The Semass facility is not open for residential drop-off on weekends, therefore, no weekend data was collected at this facility. GPI utilized this data to estimate trip rates per tonnage capacity associated with each of the facilities during the following time periods, as applicable:

- Weekday Daily
- Weekday AM Peak Hour
- Weekday PM Peak Hour
- Saturday Daily
- Saturday Midday Peak Hour

These trip rates were then applied to the proposed 500-ton capacity of the G Mello facility in Georgetown to estimate the trips generated by G Mello. Where multiple weekdays of data were collected, the trip rates from the highest day were utilized to provide the most conservative (worse case) analysis condition. Table 2 provides a summary of the resulting trip rates and site-generated trip estimates. The detailed count data is provided as an Attachment to this letter.

As shown in Table 2, the trip rates based on total trips per tonnage capacity obtained from the Auburn and Wareham facilities are significantly lower than those previously estimated in GPI's April 2019 *Updated TIAS* for the proposed G Mello facility. GPI previously estimated the proposed facility to generate 890 total vehicle trips on a typical weekday, while the rates obtained from the Auburn and Wareham facilities suggest that the proposed G Mello facility would generate only 354 to 740 daily vehicle trips. One of the main reasons for this difference may be the volume of residential waste received by the Auburn and Wareham facilities in comparison to the Georgetown facility. Approximately 67 percent of the vehicles generated by the Auburn facility were from truck trips due to a higher percentage of commercial waste received at this facility and lower volume of residential waster in comparison to the proposed Georgetown location. Approximately 31 percent of the vehicles generated

by the Wareham facility were truck trips, which is equivalent to the percentage trucks anticipated at the proposed Georgetown facility.

It should be noted that “*truck trips*” refers to commercial construction and landscape vehicles, box trucks, roll-off container trucks, packer trucks, and tractor-trailer / transfer trailer trucks. Not all of the *truck trips* generated by the facility will be tractor-trailer trucks. GPI has estimated that the proposed G Mello facility in Georgetown will generate up to 20 transfer trailers (40 trips) on a peak weekday, which represents approximately five percent of the total trips generated by the facility.

When comparing the trip rates generated by only truck trips at each of the facilities, the site-generated trips previously estimated by GPI using data provided by G Mello for the proposed Georgetown location were nearly equivalent to, but slightly higher than, the truck trips estimated using the truck trip rates obtained from the Auburn and Wareham facilities. As a significantly higher portion of the total tonnage of material processed is anticipated to be transported to the site via trucks, it is reasonable to expect that all three sites would generate similar truck trip rates per tonnage. Where the trips vary is in the number of residential (passenger vehicle) trips generated by each facility.

The counts previously collected by the GPI as the existing G Mello facility in Georgetown were collected on Saturday, April 6 to Monday, April 8, 2019, during peak spring clean-up days when the facility experienced record-high volumes. In addition, G Mello has previously noted at several public hearings that it does not intend to increase its current residential drop-off volume at the proposed facility. Therefore, the residential traffic trip rates obtained from the existing G Mello facility represent a conservative (worse case) analysis condition.

As the number of truck trips per tonnage capacity of the proposed G Mello facility is in keeping with the rates obtained from the existing Auburn and Wareham facilities, and the residential trips were based on conservative (worse case) count data collected on peak spring clean-up days, GPI believes that the site-generated trip estimates contained in the *Updated TIAS* provide a reasonable representation of the maximum potential trips to be generated on a peak day at the proposed G Mello facility.


